St. Lucie County Community Transit

Community Transit is a division of the Council on Aging of St. Lucie County and provides greater than 200,000 trips throughout the county. Community Transit is the public transit provider for St. Lucie County. One service offered is the <u>Demand-Response system</u> that has been in service since 1990. This program provides curb to curb service for a nominal fee where passenger trips are generated by calls from eligible passengers or their agents at least twenty-four (24) hours in advance to schedule a vehicle to pick up the passenger. Destinations must be within St, Lucie County. To use this service you first need to call 464-7433 and request an application. If you are approved you will be issued an ADA card which can be used for three years. You will also receive full information on how to use this valuable service.
